Professor Luis Hinojosa holds a Chair of International Law and International Relations at Granada University where he was Director of the Department of Public International Law (2009-2017) and former Director of the European Centre (1999-2009). At present, he is one of the Conveners of the Unit of Excellence *Digital Society: Security and Protection of Rights* in Granada University, and is the lead researcher in a research project on *The Public Regulation of Security in Cyberspace*. He has also been member of the Board of ESIL (European Society of International Law) (2012-2020) and was its President between 2017 and 2019. Previously, he served as Convener of the ESIL International Economic Law Interest Group (2010-2013). Between 2008-2011 he served as Coordinator of Social and Legal Sciences of AGAE (Andalusian Agency of Evaluation), the independent scientific body in charge of the evaluation of research of the 10 Andalusian universities. After working as an attorney in Brussels (Van Bael and Bellis law firm), he joined Granada University teaching staff. His main areas of teaching and research include international economic law, European Union law, and international terrorism.

As regards European law, he has published extensively on the regulation of the European Single Market, above all on the free movement of capital and the integration of European financial markets, including crypto-assets and the digital euro. He has dealt with the application of European law by national judges, European and international tax law, EU competencies, Brexit, and EU external economic relations. Within the context of international law, he has analyzed the legal and economic aspects of international terrorism, and their implications for human rights, as well as published on the concepts of sovereignty and globalization, transparency of international economic institutions, the economic analysis of law and various issues of international economic law. He has written/edited books on rule of law and the European Union's external action (2023), international economic law (2022 and 2010), justice, trade, security and individual freedoms in the digital society (2021), the international markets regulation and the erosion of the European social and political model (2019), the European Banking Union (2015), international legal instruments against the financing of terrorism (2008),

the competencies of the European Union (2006), fair trade and social rights (2002) and the international and European regulation of capital movements (1997).

Main Publications

Professor Hinojosa has been a member of the Editorial Board of the *European Journal of International Law* and the *Revista Española de Derecho Internacional*. He is a member of the Advisory Board of the *Revista de Derecho Comunitario Europeo* and of the Scientific Committee of *Ordine internazionale e diritti umani*, and member of the Executive Board of AEDEUR (Spanish Association for the Study of European Law), and member of AEPDIRI (Spanish Association for International Law), and former member of its Executive Board.

Professor Hinojosa has given conferences and taught courses in Spanish, French and English in Universities and Institutions in the USA, Latin America, North Africa, Europe and Asia. He has been invited to speak at Conferences organized in the Court of Justice of the European Union, the European Court of Human Rights and the International Court of Justice. He has been Visiting Scholar in the Stetson School of Law, Florida and in Berkeley University, California.
